I take full responsibility for the provision of the model, the performance of work according to timing. With objectivity of judging, evaluation criteria, I have no claims. I unconditionally accept the result that the juries will evaluate in the fairest way. I confirm that the results of the judging of the WULOP 2025 semifinals are not subject to protest or review.

I am informed of the rules and regulations of the semi-final championship.

## CHAMPIONSHIP REGULATIONS

- 1. I confirm that; I am not a jury in any WULOP semifinals. And I will not be jury in any WULOP semifinal in 2025.
- 2. Participation in the Championship implies full agreement of the participant with the rules of the Championship.
- 3. The inspection of the rules, specified in this text prepared by the Head Office, to be followed by the competitors will be carried out by the country representative in the semifinal stage. The rules to be followed in the competition will continue to be valid in the final stage as well as in the semi-final stage. All participants must comply fully with the championship rules. Otherwise, sanctions determined by the country representative may be applied in the semi-final stages or the competitor may be disqualified. In the final stages, if the competitor does not comply with the rules, the discretion for sanction and disqualification belongs to the head office.
- 4. If a *participant or model is late, absent, refused or canceled* to participate in the Championship, the payment will not be refunded.
- 5. Participants must be ready at least one hour before the application time, together with the live application model in the area where the semi-final will be held. The participants have to find the model they will do the application on themselves. The entire responsibility of the model belongs to the participant who will do the application.
- 6. During the Championship, the jury observe and controls compliance with the rules and records violations.
- 7. Each model must be photographed before starting the procedure. Re-photographing will take place immediately after completing the procedure and drawing the image as a whole.
- 8. Before the start of the procedure and during the Championship, it is forbidden to use decorative cosmetics (except pencils).
- 9. The duration of the procedure is 2 hours for microblading and other 4 categories 2,5 hours, taking into account the application of an anesthetic and subsequent drawing of the image. It will be given 15 minutes to prepare the workplace and 15 minutes to clean the workplace. The Jury considers the readiness of the participants, their workplaces and models.
- 10. Participants and models are <u>not allowed</u> to leave the competition area from the start of the Championship until the announcement of the end of the competition. For violation of the rules, the master may be disqualified or receive penalty points.
- 11. The model's face must not have decorative cosmetics and / or previously made permanent makeup.
- 12. Models must sign an informed voluntary consent to become familiar with the General rules and take responsibility for the result of the work done.
- 13. Models must give written permission to shoot and publish their work.
- 14. Anyone who has reached the age of 18 can become a model.
- 15. The Dress Code for models is a white t-shirt and black trousers.
- 16. The participant's Dress Code must be white medical uniform or white medical gown with a long sleeve or 3/4 sleeve. When using a shorter sleeve, it is mandatory to use an oversleeve.
- 17. Indoor shoes necessarily.
- 18. The participants of the championship should collect the hair in the tail.
- 19. All removable parts of the handle of the needle + nozzle system must be in a Kraft bag. This does not apply to modular handles.
- 20. Put a mask and caps on our hair and a model's cap without gloves
- 21. Bracelets, watches and rings must be removed.
- 22. First, wash your hands, then treat with alcohol-containing disinfectant (issued at the competition) and put on gloves.
- 23. Before the procedure, we treat the model's skin with an alcohol-containing disinfectant.

- 24. The sketch is applied with a pencil, you must make a fresh cut and this cut must be treated with a skin sanitizer.
- 25. The potion of the mirror with a handle on the top shelf of the table, chair and its back, lamp, all jars including lids should be wrapped with tape. The handle of the device and the cord are placed in a barrier protection and secured with a special tape.
- 26. If you touch your phone, face, hair or any other material while working, make sure to change your gloves.
- 27. If you move the table while working, you need to take off your gloves, move the table, put on new ones and disinfect it.
- 28. If you were wearing gloves and picked up an extension cord, you need to change your gloves.
- 29. Phones must be disinfected and wrapped in film; they can be used only for photos. To talk on the phone while you're working is forbidden.
- 30. The participant must follow all hygiene rules that are required for this procedure.
- 31. Keep the workplace clean and tidy;
  - clean the workplace after performing the procedure
  - throw it in the trash can have used disposable materials
  - follow the rules of asepsis and antiseptics
- 32. The participant must keep the safety of the procedure, being responsible for the health of the model and the results of their work.
- 33. The competitors accepts that they have read and understood the rules in this text and will fully comply with all articles.
- 34. The competitors cannot post any photo of the live model before the competition and the competition day in any social media and cannot share the photo with anyone. Who share the live model photo will be disqualified from the competition.
- 35. Models cannot leave the area before the scoring has been finish. If any model left without any permission will be disqualified from the competition. Models are under responsibility of competitors.

## WORKPLACE OF A WORLD CUP PARTICIPANT

- 1. The organizer of the Championship provides each participant with a workplace:
  - armchair
  - specialist chair
  - cosmetic table
  - lamp

- mirror
- trash can
- 2. The other supplies and equipment are provided by the participant on their own:
  - device certified for permanent makeup;
  - disposable tools, needles, cartridges certified;
  - certified pigments;
  - certified disinfectant for the skin;
  - pencils, brushes, sharpeners;
  - anesthetic:
  - set of cosmetologist's clothing (including a cap);
  - Shoe covers or replacement shoes;
  - tweezers, etc. (everything relative to the procedure).
